The MPUC referred the matter to the Minnesota Office of Administrative Hearings for a contested case proceeding to examine service quality concerns raised by the CWA. This proceeding relates to voice service and does not relate to broadband/internet services.

In-person and virtual public hearings will be held to listen to comments from members of the public and answer questions. Comments are encouraged to discuss CenturyLink's performance related to voice service. All comments received during these hearings will be considered by the MPUC when final decisions are made.
